

NCUA Supervisory Examiner Steve Worden will discuss the importance of succession planning to a credit unions long-term success. The presentation will include a review of succession planning from an emergency perspective as well as the more common developmental and retirement situation. It will address the importance of leadership continuity to the performance of a credit union and how planning for the replacement of key leaders will help ensure success.

Consumer Payments: Insights, Trends & Technologies - Robert Jarosinski
